## PARTICIPANT

In consideration of being allowed to participate in any way in the Uihlein Soccer Park athletics/sports programs, related events and activities, the undersigned acknowledges, appreciates and agrees that:

- 3. I willingly agree to comply with the stated and customary terms and conditions for participation. If, however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attentions of the nearest official immediately; and
